- 2. Landscape Structures Products. "**Products**" means products which meet the following qualifications ("**Products**"):
- (a) standard or custom park and playground components and playground installations and design ideas; and
- (b) standard or custom shade components and shade installations and design ideas; and
- (c) standard or custom water components and water installations and design ideas.
- 3. License. LSI hereby grants you a worldwide, royalty-free, non-exclusive, perpetual (for the duration of the applicable copyright) license to exercise the rights in the Digital Assets as stated below for the purpose of promoting LSI Products:
- 3.1. To reproduce the Digital Assets, to incorporate the Digital Assets into one or more collective works ("Collective Works"), and to reproduce the Digital Assets as incorporated in the Collective Works; and
- 3.2. To distribute copies or phonorecords of, display publicly, and perform publicly the Digital Assets including as incorporated in Collective Works.
- 3.3. The rights pursuant to Sections 3.1 and 3.2 may be exercised in all media and formats whether now known or hereafter devised. The above rights include the right to make such modifications only as are technically necessary to exercise the rights in other media and formats, but otherwise you have no rights to make derivative works. All rights not expressly granted by LSI are hereby reserved.
- 4. - 5.4. You may not exercise any of the rights granted to you above in any manner that is primarily intended for or directed toward commercial advantage or private monetary compensation; and
- 5.5. If you distribute, publicly display, or publicly perform the Digital Assets, your customers and potential customers must keep intact all copyright notices for the Digital Assets and give Landscape Structures credit reasonable to the medium or means they are using.
- 5.6. You may only distribute or publicly display images of individuals especially children to promote, sell, install and service LSI products.
